

Student Right-to-Know Disclosure July 1, 2020

In accordance with the federal *Student Right-to-Know Act*, and to assist you in making an informed decision about your education, West Coast Ultrasound Institute has provided its graduation, transfer-out, retention and student body diversity rates as reported by the school in connection with the Integrated Postsecondary Education Data System (IPEDS) Survey. **This Student-Right-to-Know disclosure is updated annually and available as of July 1st.**

Annual Graduation Rate: 76%

The graduation rate is calculated based on a fall cohort of full-time, first-time, degree/certificate-seeking students, who entered during the Fall 2013 term and who completed their program within 150% of the normal time as of August 31, 2019. The graduation rate is based on data reported by the school in connection with the 2019-20 IPEDS Winter Collection (Graduation Rate Survey). This rate does not include students who left school to serve in the armed forces (or have been called up to active duty), on an official church mission, or with a foreign aid service of the federal government, or for students who died or became permanently disabled.

Annual Transfer-out Rate: 0%

The transfer-out rate is calculated based on a Fall 2013 cohort of full-time, first-time, degree/certificate-seeking students, who are known to have transferred out of the school within 150% of the normal time as of August 31, 2019. The transfer-out rate is based on data reported by the school in connection with the 2019-20 IPEDS Winter Collection (Graduation Rate Survey).

Annual Retention Rates: Full-Time 79% / Part-Time N/A

Annual retention rates are calculated based on the percentage of full-time, first-time, degree/certificate-seeking students, as of the Fall 2018 term. The retention rate is based on data reported by the school in connection with the 2019-20 IPEDS Spring Collection (Fall Enrollment Survey).

Federal Pell Grant Recipient Rate: 32%

Percentage of Federal Pell Grant Recipients is based on all undergraduate students enrolled in Fall 2018. The Pell Recipients percentage is based on data reported by the school in connection with the 2019-20 IPEDS Winter Collection (Student Financial Aid Survey).
